I am writing to follow up on my Public Records Request regarding the traffic signal located at the intersection of West County Line Road and Highland Colony Parkway. For your reference, I am attaching the written response I received from the City of Ridgeland. In their communication, Ridgeland clearly states that: The traffic signal is owned and operated by the City of Jackson, and Ridgeland does not receive video feed from this signal and does not maintain related operational records. However, your office previously indicated that the City of Jackson does not possess responsive records related to this traffic signal. With all due respect, these conflicting statements create serious concern. It is not reasonable to conclude that a functioning traffic control device—located at a major intersection and used daily by the public—is operating without any documented maintenance, calibration, inspection, or operational oversight. This is not only a public records issue, but also a matter of public safety. Traffic signals directly affect the safety of drivers, pedestrians, and emergency responders. A lack of clarity regarding who maintains and calibrates such equipment raises legitimate concerns about ongoing risk to the community. I am not seeking to assign blame. My sole objective is clarity and transparency. Accordingly, I respectfully request that the City of Jackson confirm, in writing: Whether it is the custodian of the technical and operational records for this traffic signal, including maintenance, calibration, and programming; If such records exist, that they be produced pursuant to the Mississippi Public Records Act; and If the City of Jackson is not the custodian, that a formal certification of non-custody be provided, identifying the entity that is responsible for the signal's operation and maintenance. Thank you for your attention to this matter. I trust this issue can be resolved promptly in the interest of transparency and public safety.
